Project Name & Application	Village at Novato Mixed-Use Project P2020-037
Project Location & APNs	7530 and 7506 Redwood Boulevard (Assessor Parcel Numbers [APNs] 143-011-05 and 143-011-08)
Project Description	Proposed General Plan Amendment, Zoning Map Amendment, Use Permit, Design Review and Density Bonus request for the Village at Novato mixed-use project, which includes three (3) separate buildings that include 178 residential units, 14,000 square feet of commercial space and approximately 400 surface parking spaces. The buildings consist of one (1) 3-story building with retail on the ground floor, and 26 residential units on the upper two floors, and two (2) 4-story buildings with a combined total of 152 residential units. Additional site improvements include a common green area, frontage improvements along Redwood Blvd. (i.e., bike lane, sidewalk, street parking) and a pedestrian walkway. Additionally, the project proposes to include below-market-rate units affordable to Low-Income and Very Low-Income households, which would qualify the project for a density bonus.
