Hello,

I hope everyone has been enjoying their summer along Tomales Bay, particularly with the peace of mind that your wastewater system continues to work well. This is a quick update on the following:

Current Operation and Maintenance Fee

This year's annual O&M assessment will be \$1,186 per equivalent single-family dwelling (ESD.) This reflects the 3.2% Bay Area cost-of-living increase from last year. These O&M fees pay for operating costs, monitoring/sampling, laboratory expenses, reports to the state, response to emergency calls, inspections, annual state permits, maintenance, and district administration. This fee is included in your property tax assessment and payable in two installments. The bill for the first installment will be mailed by the County Assessor's Office the first week of October.

Most properties will see the \$1,186 fee on their tax bill. For those properties that have more than 1 ESD, the O&M fee is calculated by multiplying the assigned ESD by \$1,186. For example, the annual fee for a parcel assigned 2.5 ESD will be \$2,965.

NEW Operation and Maintenance Operator

This is a reminder that our new operation and maintenance contractor is **Natural Systems Utilities (NSU.)** If you have a problem, call their 24-hour number: **707-254-1931.** By now, new decals with their emergency contact information are on your electrical panels.

If your STEP pump alarm goes off, immediately call NSU and provide your name, phone number, property address, how long the alarm has been sounding, and any other observations that may be helpful to the maintenance personnel. If you rent your property, leave clear instructions to all tenants explaining the residence is on a septic system and what to do if the power is out or the alarm goes off. Make sure your instructions have been updated with NSU's telephone number.
